This administration fee will be applied in addition to the 2023 registration fees if a horse's Step 2 registration is incomplete. Note: Until Proof of Parentage is confirmed inspection results will not be released.		
Test Rider Fee	Minimum \$ 100.00 The owners of stallions opting to have their stallion's athleticism assessed by jumping will require a test rider appointed by the IDHSC board. Test rider fees will be applied.		
Refund of Fees	If IDHSC cancels inspection, a full refund will be issued to all horse owners who submitted a completed application (application + fees). If a horse is withdrawn prior to the application closing deadline, a refund of fees may be requested by the Applicant by emailing the Society. Request for refund must be accompanied by a veterinary note. Extenuating circumstances may be considered by the Board. Approval of the refund will be dependent on the costs incurred by the IDHSC to plan and put on inspection.
