Refund Policy: If IDHSC cancels inspection, a full refund will be issued to all horse owners who submitted a completed application (application + fees).

If a horse is withdrawn prior to the application closing deadline, a refund of fees may be requested by the Applicant by emailing the Society. Request for refund must be accompanied by a veterinary note. Extenuating circumstances may be considered by the Board. Approval of the refund will be dependent on the costs incurred by the IDHSC to plan and put on inspection.

Athleticism Assessment

Stallion aged 3 years or older are required to have their athleticism assessed by means of a loose jumping demonstration.

MERIT – Irish Draught Sport Horse Stallions:

Approved Irish Draught Sport Horse stallions are evaluated for 1 star for athleticism. Applicant and may choose loose jumping, or under saddle evaluation for IDSH stallions over 4 years of age (under saddle evaluation has an additional \$800 fee for the test rider and course).

ADDITIONAL MERIT- Irish Draught Stallions:

The owners of Irish Draught stallions that are 4 years or older and meet the requirements to be classified as 'Class 1' can opt to have their stallion's athleticism assessed by jumping the stallion over a course of fences at 1.00m level under saddle for an additional merit. Irish Draught stallions that achieve an above average score of 70% or over at the athleticism assessment will be awarded a bronze merit for their own performance in the discipline of show jumping. There is an additional \$800 fee for test rider and course.
