If a horse is withdrawn prior to the application closing deadline, a refund of fees may be requested by the Applicant by emailing the Society. Request for refund must be accompanied by a veterinary note. Extenuating circumstances may be considered by the Board. Approval of the refund will be dependent on the costs incurred by the IDHSC to plan and put on inspection.
